



DESCRIPTION

Roof Cleaner Bio Wash is for the treatment of organic contaminations on roofs & associated surfaces. It is a concentrated solution which should be diluted from 1:5 (general/light contaminations) to 1:3 (more severe contaminations) with clean water. This product should be sprayed onto any roof tile where contaminations of algae, lichen, slimes etc occur. Spray on & simply leave this powerful cleaning agent to work over the following days, weeks & months. No rinsing is required after the application of the product. Inhibits the return of organic contaminants & black spotting when applied once or twice per year.

Suitable for use on marley roof tiles, general concrete tiles, clay tiles, natural stone, general cement-based tiles, slate tiles, plastic tiles, composite tiles, & metal tiles. Does not have an adverse effect on UPVC windows, lead flashing or metal frames.

This product will make 30 litres of ready to use solution which covers up to 125m² of surface area.

USES

Removes green organic contaminants such as moulds, algae's, slimes etc. Apply to:

- Natural stone i.e. sandstone/slate etc
- · Clay tiles.
- · Concrete/cement tiles.
- Composite tiles.
- Inhibits the formation (and reinfestation) of organic contaminants.
- · Plastics & metals.

COVERAGE

Approximately $5m^2$ per litre (when diluted 1:5) Total max coverage per $5L = 125m^2$

DIRECTIONS OF USE

- Carry out a test in an inconspicuous area.
- If you find this product is not suitable for use on your project do not continue to
- Dilute from 1:5 (light contaminations) to 1:3 (severe contamination) with clean water.
- Apply to dry surfaces with a sprayer or watering can.
- Do not apply when rain is predicted in the next 12 hours.
- Do not exceed more than 5m² per litre of diluted solution.

- Do not wash this product off the surface once treated.
- Inhibits the return of algae, lichen, slimes and other organic contaminations.
- The product is suitable for use at any time of year.
- Do not exceed the coverage rates.
- Safe for children, pets & wildlife when dry.
- Do not spray onto adjacent plants and lawns or allow the product to mist over them.
- Do not allow this product to enter ponds.

CONTRAINDICATIONS

- Do not rinse off, the product must be allowed to dry on the surface.
- · Do not allow the product to travel into ponds.
- Do not apply if rain is likely within 12 hours.
- No need to apply neat always dilute!
- Once diluted do not exceed a coverage rate of more than 5m² per litre.
- Heavily saturate thicker build ups of green organic contaminants.
- Allow the product to work for at least one week.
- This product is not a general weed killer to be used on plants.

PACKAGING

This product is non-flammable. Store in original container in a cool dry place, out of direct sunlight. Do not allow to freeze. Keep out of reach of children.

SHELF LIFE

The maximum shelf life is 24 months.

- Apply diluted with water from 1:3 (severe contaminations) to 1:5 (lighter general contaminations).
- You must saturate the surface, particularly when applying to thick green growth.
